About Craftspace

Craftspace is a charity creating opportunities to see, make and be curious about exceptional contemporary craft. We do this through different scales of touring exhibitions and cross artform productions, participatory projects, action research and consultancy.

We receive investment from Arts Council England as a national portfolio organisation in recognition of the high quality of our work and our 30 year track record. Craftspace is an educational charity and non-profit company limited by guarantee.

Management and governance

Craftspace operates with a small experienced team of 5.4 full time equivalent staff led by the Director Deirdre Figueiredo, MBE.

The Board is led by our Chair Matthew Rhodes, a former business owner and experienced non-executive director in energy sustainability and currently has five other Trustees. These are non-executive voluntary roles. The board plays an essential role in ensuring good governance whilst supporting advocacy, fundraising and development of the organisation's strategic and business plans.

Our Work

In 2012 Craftspace and its corporate partner VSM UK Ltd were the overall winner of the Arts & Business category of Business in the Community's Awards for Excellence.

An example of our innovative approach is a creative partnership with Arts Alive rural touring circuit and Birmingham Contemporary Music Group to commission Field Notes, a unique collaboration between composer Howard Skempton and Matthew Harris **fieldnotestour. co.uk**

Over the next three years we are developing an exhibition about craft and the commons, curating a series of cross artform productions and developing participatory projects with a focus on families making together, social justice, community asset building and migration.

- Work to avoid conflicts of interests and declare interests
- Evaluate the performance of the organisation and the performance of the board itself
- Enact our policy and procedures in relation to equality of opportunity and respect our code of conduct
- Attend and contribute to quarterly board meetings

Trustees will be involved in:

- Feeding into the business planning process and policy development to ensure
- Ensuring Craftspace is operating strategically
- Supporting the organisation to find new sources of income and feeding into the implementation of a fundraising strategy
- Building, strengthening and maintaining relationships with our core funders, donors and current or potential stakeholders
- Acting as a sounding board for our staff team and sharing knowledge in your area of expertise
- Bringing a range of connections from the wider artistic and business communities to grow our work, operating environment and partnerships

Key Information

- The basic time commitment from trustees is attendance at four meetings per year, plus an annual away day. There are occasional time-limited sub group meetings to address particular development needs or issues. We also encourage trustees to participate in training where appropriate.
- Board papers are sent in advance of meetings and preparation for discussion prior to the meeting is expected.
- Meetings are currently held at the Craftspace offices in Birmingham.
- The role of a trustee is voluntary and is not remunerated, but reasonable expenses will be paid.
- We believe it is vital that board members see and experience our programme and also encourage members to represent the organisation at networking and other events where possible.

Why Join?

Craftspace is a nationally significant organisation working with people in all walks of life. It's an opportunity to give something back to the community while meeting new people, learning new things and coming into contact with exceptional contemporary craft. This is an interesting time to join the board as Craftspace continues to develop its reputation and scope from a very strong financial, reputational and artistic base in the sector. We welcome applications from people seeking an introduction to working at board level and as non-executive directors, as well as more experienced candidates.
